



Beautiful Bulldogs of Texas Health Guarantee

This agreement is made and entered in on _____ by and between _____ and Carla Rutherford for the purpose of setting forth the terms and condition of the purchase by buyer of a purebred English Bulldog from the litter whelped on _____ out of sire _____ and dam _____.

The seller agrees to sell and the buyer agrees to buy a puppy from the litter described above. Buyer will pay for the puppy in accordance with the terms of this contract.

Ownership of the puppy will be transferred to the buyer for the sale price of \$_____ to be paid before the dog leaves the seller premises, plus shipping if applicable.

Seller guarantees that the puppy is in good health and has received appropriate vaccinations for distemper and parvo. The puppy has been wormed bi-weekly. A health shot record and the AKC registration paper will be provided at time of delivery. Buyer is advised to have puppy examined by a competent veterinarian (preferably with experience with the bulldog breed) within 48 hours from the time the puppy is exchanged with seller. If the vet does not find the dog in good health as outlined in this guarantee they should state in writing. Buyer must notify seller immediately. Seller reserves the right to have the dog reexamined by our veterinarian at our expense. If the diagnosis is confirmed by our vet, seller will resume possession and give buyer a credit towards another dog.

If the puppy dies from a genetic defect within the first year, proven by an autopsy by a licensed veterinary in writing backed by test results, a new puppy will be provided at no cost. Minor breed related and treatable or correctable conditions or any condition which could go away or is considered to be a condition which the puppy will outgrow are not covered, such as but not limited to cherry eyes and skin problems. Buyer is responsible for all vet bills incurred prior to return and transportation cost to return. The guarantee is effective until the puppy is of one year of age. Although a concentrated effort is made by seller to breed sound and healthy puppies, buyer should understand that due to the nature of the breed, bulldogs are predisposed to certain medical abnormalities and that a normal bulldog may have one or more of these conditions in a lifetime. The buyer is urged to research the breed and be familiar with all health issues that could affect their bulldog before entering in an agreement to purchase a bulldog.

This dog is warranted only for the purpose of being a pet and companion. Spaying or neutering is strongly recommended, and no warrant given to the buyer for any special purpose of function of this dog. It is further understood and agreed that no warranty or representation has been made with respect to the above described puppy except as set forth in writing in this agreement.

If the puppy is unsatisfactory and is to be returned to seller, it must be done within the time of 1 week and at the buyer's expense and must be in the same condition as when it left seller.

The intent of this contract is to provide buyer with a quality pet with no guarantee of show quality. No warranties or guarantees other than those state have been given or implied.

Due to the varying kinds of dog food on the market and the different environmental conditions the dog comes in contact with, we will not guarantee the dog unless they're given NuVet Plus daily at the manufactures suggested dosage for one year. Failure to do so makes this guarantee null and void.

Our guarantee does not include poisoning, accidents, negligence or behavioral problems, as training philosophies and environments vary amongst individuals.
